COMMON QUESTIONS ABOUT SECONDMENTS

How long is a secondment?

Normally the assignment runs for a period of two years, with the possibility of a one-year extension. Shorter term secondments may be considered for specific assignments.

Who is responsible for supervising a person on secondment?

ICCROM assumes responsibility for the functional and technical supervision of secondees. Secondees are also subject to ICCROM's staff regulations and rules when performing their duties.

Does this mean secondees are employed directly by ICCROM?

A secondee remains an employee of their releasing institution throughout the secondment period. Salary, allowances, pension benefits, insurance and other secondment-related costs are met by the releasing institution.
